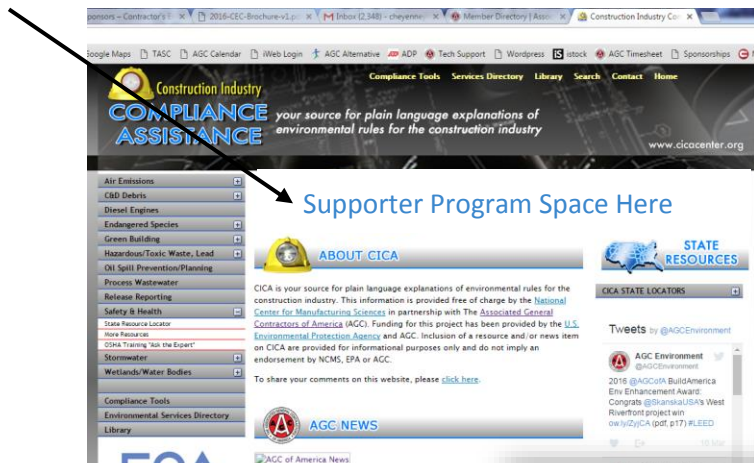

## The CICA Center Is:

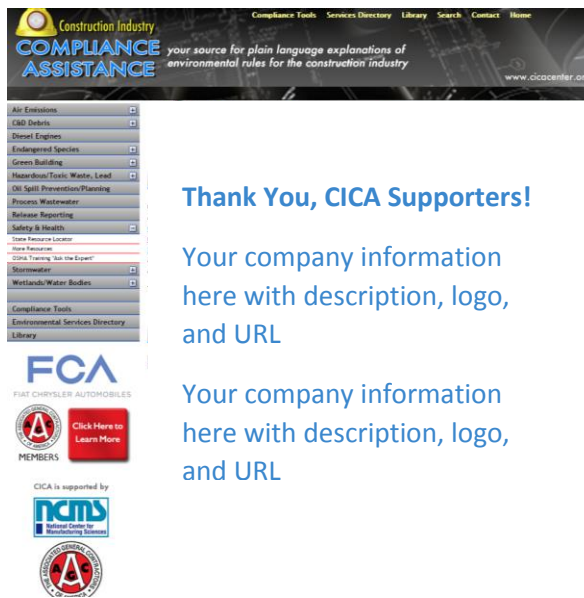

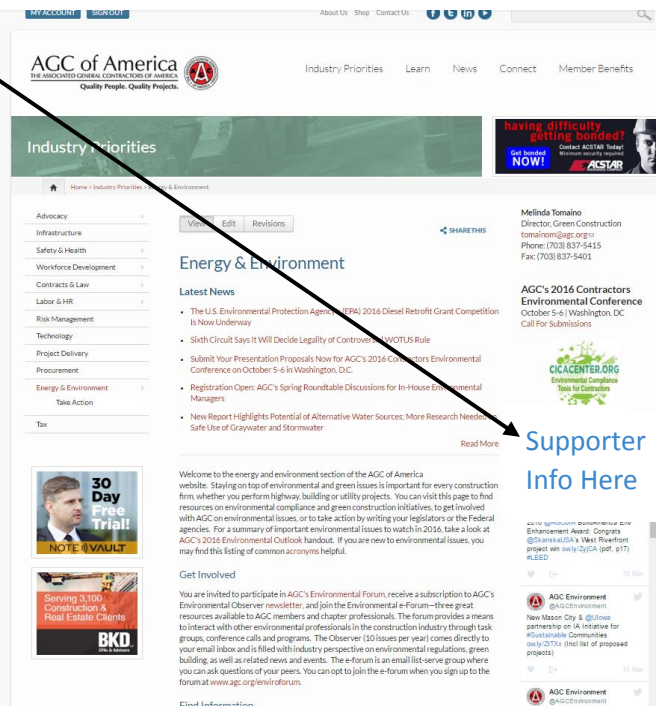
